Sealed bids for furnishing the City of Augusta with its requirements of Uniforms on an as needed basis as specified below and in the attached specifications for a period beginning at award of bid until June 30, 2020. All bids will be received by the City Manager, c/o Development Services Office-1st Floor, 16 Cony Street Augusta, Maine, 04330, until 2:00 P.M., on May 22, 2019 at which time they will be publicly opened and read aloud.

Bids shall be submitted on the attached form in sealed envelopes plainly marked "**RFSB No. 219074 - Uniforms for Police Department**" and shall be addressed to the Purchasing Agent at the above address.

Successful bidder shall visit each department, measure all personnel twice a year for proper fit and keep a file on all sizes. Bidder must have a tailor or seamstress on the premises capable of making all alterations, at no extra charge that will insure a good fit to the department's satisfaction.

All shipping and postage charges are to be paid by successful bidder including items returned by the City.

Material offered is to be brand new, the latest available, and of good quality and workmanship. The bidder will state in the proposal, the brand name and style number, if any, and delivery time of all items they propose to deliver. The brand name and style number stated shall be for material that will meet all the specifications.

Each section, as shown in the proposal, will be awarded separately and will be awarded to the lowest bidder meeting all the specifications based on the average of the last three years purchases.

There are approximately 40 members of the Police Department for whom the police department uniforms will be purchased.

The City of Augusta makes no guarantee whatever as to the quantity to be purchased during the period of award and the City reserves the right to increase or decrease any of the items called for or to wholly omit any item or items.

The City may request samples of any or all of the items.

This proposal, if accepted, shall become a contract and shall remain in effect during the period stated herein unless terminated at the request of the City of Augusta upon 30 days written notice, or immediately "for cause".

In the event that the successful bidder(s) to whom the bid has been awarded should fail to supply the City of Augusta's requirements promptly and according to the specifications and prices of this bid, the City reserves the right to cancel the award to the bidder(s) and purchase the uniforms elsewhere.

The City of Augusta reserves the right to extend the contract as it expires for a year at a time up to and including a total of three years if mutually agreeable.

Since a prompt delivery is needed, delivery time as well as price may be made a factor in determining the award of this bid.

It is the custom of the City of Augusta to pay its bills within 20 to 30 days following delivery of and receipt of bills for all items covered by the purchase order. In submitting bids under the attached specifications bidders should take into consideration all discounts, both trade and time, allowed in accordance with the above payment policy. All bidders should quote net prices, therefore, exclusive of all Federal Excise Taxes.

The City of Augusta, Maine reserves the right to waive all informalities in bids, to accept any bid or any portion thereof, or to reject any or all bids should it be deemed in its best interest to do so. Except as otherwise required by law or as specifically provided to the contrary herein, the award of this bid shall be governed by the City's purchasing ordinance.
