213 ORDERED, That Davis Street (formerly shown on plan as Underhill Street) description below, be accepted as a City Street.

A certain lot or parcel of land situated on the west side of the Kennebec River in Augusta, Maine: Beginning at the northeasterly corner of Lot No. 8, Block No. 1 as shown on "Map of Buena Vista Park" made by A. M. Johnson in May, 1940 and recorded at the Kennebec County Registry of Deeds in Plan Book No. 13, Page 56 to which reference is made for clarifying detail; thence running southwesterly 50 feet along the westerly side of "Underhill Street" (now known as Davis Street) to the southeasterly corner of Lot No. 8, Block No. 1; thence turning a 90 degree angle and running 50 feet southeasterly to the southwesterly corner of Lot No. 6, Block No. 3; thence running northeasterly 50 feet to the northwesterly corner of Lot No. 6, Block No. 3; thence turning a 90 degree angle and running 50 feet northwesterly to the point of beginning.

Meaning and intending to describe a parcel of land 50 feet wide and 50 feet long extending southwesterly from the southwesterly end of presently accepted Davis Street to be used as a City Street, known as Davis Street.

343 ORDERED, That Davis Street, description below, be accepted as a City Street.

Beginning at a point that is 317.02 feet easterly along the southerly side of Forest Avenue from its intersection with the easterly side of Northern Avenue; running thence southerly and at right angles thereto a distance of 200 feet; running thence easterly and right angles thereto a distance of 50 feet; running thence northerly and right angles thereto 200 feet to the southerly side of Forest Avenue; running thence westerly and right angles thereto along the southerly side of Forest Avenue a distance of 50 feet to the point or place of beginning.

Meaning and intending to describe a rectangular Parcel of land 50 feet wide and 200 feet long to be known as Davis Street.

Know All Men by These Presents,

That We, Clement O. Dostie and Blondinette Dostie, husband and wife, both of 11 Davis Street, Augusta, County of Kennebec and State of Maine,

in consideration of One Dollar (\$1.00) and other valuable considerations

paid by the Inhabitants of the City of Augusta, a body corporate, located at Augusta, in the County of Kennebec and State of Maine,

the receipt whereof we do hereby acknowledge, do hereby give, grant, bargain, sell and convey unto the said Inhabitants of the City of Augusta, their successors

and assigns forever, a certain lot or parcel of land situated in Augusta, County of Kennebec and State of Maine, bounded and described as follows, to wit:

Beginning at a point on the southerly line of Quirion Avenue, as shown on Plan of Buena Vista Park recorded in Kennebec Registry of Deeds in Plan Book 13, Page 56, which point is located at the northeasterly corner of Lot 12 in Block 1 as shown on said Plan; thence proceeding in a generally southerly direction along the easterly side lines of Lots 12, 11, 10 and 9 in said Block 1, two hundred fifty feet (250') to the southeasterly corner of said Lot 9 of said Block 1; thence at right angles and proceeding in an easterly direction fifty feet to the southwesterly corner of Lot 5 of Block 3, thence at an angle and proceeding in a northerly direction along the westerly sidelines of Lots 5, 4, 3, 2, and 1 of said Block 3; two hundred fifty feet (250') to the southerly line of said Quirion Avenue and the northwesterly corner of said Lot 1 of Block 3; thence at an angle and proceeding in a westerly direction fifty feet (50') to the point of beginning to be known as Underhill Street all as shown on above mentioned recorded plan.
