Beg. at S & S on the S. side of the Co. rd. lead. from Ken. Br. to the schoolhouse & abt. 30 1/2 R. E.ly of sd. Br. Th. run. S. 4 W. 53 R. S. 17 W. 77 1/2 R. to the cor. of a bd. fence; which cor. is 20' N. of the dividing line of land owned by Wm. Brooks and Sam'l Cony. Th. E. 23 18" S. 72 R. to the Co. Rd. the first two courses mentioned being on the E. side of sd. rd. & the last men. course on the N. side of sd. rd.. The rd. to be 3 R. wide from mon. beg. at to Wm. Brooks N. line and from thence 40' W. to the Co. Rd.

Above is Arsenal St. and Eastern Avenue.

See actual order for correct discription. Alderman's record gives general discription, as per petition.

Beginning at a point in the easterly line of Arsenal Street, in the southerly line of Eastern Avenue extended easterly across Arsenal; thence, N. 59 34' W, said course being a continuation of the southerly line of that part of Eastern Avenue lying between Hospital Street and Arsenal Street, two hundred and thirty-four and eleven hundreds feet (234.11); thence, N 30 24' E., thirty (30) feet; thence S 59 34' E., to the easterly line of Arsenal Street; thence, S 29 19' W., thirty (30) feet, more or less, to the point begun at. Meaning and intending to accept as a city street, that part of Eastern Avenue laying Westerly of Arsenal Street, for a distance of two-hundred and thirty-four and eleven hundred (234.11) feet Westerly of Arsenal

Street. Said street to be thirty (30) feet wide. All as shown on “Plan of Eastern Avenue, West of Arsenal Street,” made by the City of Augusta Engineering Department, November 7, 1947, and on file with the City Clerk.
