The Augusta Historic Preservation Commission sponsors a program to recognize historic buildings in Augusta. The intent is to identify our historic buildings (such as houses, barns, stores, and public structures), to call attention to the historic character of the city, and to recognize these early buildings and the people connected to them.

Owners of buildings 50 years old and older are eligible to apply for the building plaque. The name and date on the plaque will be based on historic information and determined in consultation with the current owner. The plaque is to be affixed to the street side of the building.
