TITLE: Jackson Street - Discontinuance

**ORDERED,** That a section of a city street known as Jackson Street, description below, no longer of public use and necessity be discontinued:

DESCRIPTION: All that part of Jackson Street, so-called, lying generally westerly of the State of Maine Office Building from the point of the prior discontinuance at Hayden Lane, so-called, southerly to Kennedy Brook. The intent being to discontinue all of Jackson Street currently remaining as a Town Way.

The City of Augusta shall not retain a public easement over the herein described area, as provided in Title 23, M.R.S.A., Section 3026.
