A-302 Highway Committee



This was the regular monthly meeting of the Augusta City Government, 7 Aldermen and 13 Councilmen were present.

REPORTS OF COMMITTEES

- A-302 Report of Highway Committee.
That the City Treasurer be and is hereby authorized to pay to Hanna T. Reynolds the sum of \$200, said sum being reimbursement to said Reynolds for expense to her caused by construction work on Arsenal St. and flow of drainage water therefrom and said sum to be paid from the Contingent Fund. Voted ought not to pass. Voted to sustain recommendation.
- A-303 That the City of Augusta maintain a road known as the Togus Stream Road. 20 petitioners admitted. See Henry D. Berube Recommend plowing in winter. Recommended that it be placed on file. Voted to sustain recommendation.
- #### IN BOARD OF ALDERMEN
- The following orders were read and passed.
- A-304 Roll of Accounts in amount \$ 94,566.71 was passed by both branches of the City Government with the following vote: Aldermen 7 yeas and no nays, Common Council 13 yeas and no nays.
- A-305 ORDERED, That the City Treasurer be and is hereby authorized to accept from Mabel Blaisdell the sum of \$460.91 as payment in full of taxes, interest and costs on taxes from 1935-47 on land on the Gould Road and Belgrade Road taxed to Edward L. Lovejoy Heir. And be the Treasurer further authorized to execute a quitclaim deed to said Mabel Blaisdell of the City's interest in and to said premises on payment of said sum within 30 days of the date hereof.
- A-306 ORDERED, That the City Treasurer be and hereby is authorized to accept from Maurice Ricker the sum of \$30.00 in full payment of 1946 tax lien for land on Winthrop Road taxed to Marion C. Drew, as per recommendation of Board of Assessors. And be it further ordered that the Treasurer be and is hereby authorized to execute a quitclaim deed from the City to said Ricker on payment of the same as a release of the City's claim to said premises by virtue of said taxes.
- A-307 ORDERED, That the City Treasurer be and hereby is authorized to accept from Carrie Graves the sum of \$4.40 for 1947 tax lien for Lot 375 Land Fox Glen, as per recommendation of Board of Assessors. And be it further ordered that the Treasurer be and is hereby authorized to execute a quitclaim deed from the City to said Carrie Graves on payment of the same as a release of the City's claim to said premises by virtue of said taxes.
- A-308 ORDERED, That the Mayor be and is hereby authorized to execute a Notice of Quit to Fifield Bros. Co. and covering premises owned by the City and now occupied by said Company at the corner of Commercial and Oak Streets, being a gasoline station and rest rooms.
- A-309 ORDERED, That the city of Augusta purchase a two-way radio to be placed in any piece of fire equipment at the Mayor's discretion. And the sum of \$550.00 is hereby transferred from the Fire Department appropriation to be used for the purchase of same.
