TITLE: Discontinuance - Park Street

ORDERED, That a city street known as Park Street, description below, no longer of public use and necessity be discontinued:

DESCRIPTION:

Beginning at a point on the northerly side of Riverside Cemetery and on the westerly side of Bangor Street, then running northerly a distance of 38' to the corner of land owned by Stephen Field (Assessor's Map 39, Lot 34A), thence running westerly for a distance of 380'; thence running southerly a distance of 38' to a point on the northerly boundary of Riverside Cemetery; thence running easterly for a distance of 380' to the point of beginning. Meaning and intending to describe that portion of Park Street 38' wide and 380' long as shown on Assessor's Map 39, dated June 7, 1996.

It is requested that a public easement over the herein described area not be retained, as provided in Title 23 M.R.S.A. Section 3026, except that a management/maintenance/repair easement be retained for cemetery operations and public utilities; and an access easement be retained for the property owner(s) of lot numbers 32 and 35B, Assessor's Map 39.
