Know All Men by These Presents,

That I, Eva Fontaine, of Augusta, in the County of Kennebec, in the State of Maine

in consideration of one dollar and other valuable considerations,

paid by City of Augusta, a Municipal Corporation, in said State of Maine,

the receipt whereof I do hereby acknowledge, do hereby give, grant, bargain, sell and convey unto the said City of Augusta, its successors

and assigns forever, a certain lot or parcel of land situated in said Augusta, and bounded and described as follows:

Beginning at the south east corner of lot numbered nineteen (19) as delineated on Plan entitled "Lots on Northern Avenue formerly owned by Jas S. Norton surveyed June 2, 1940 by H.F. Hill" which plan is to be recorded in the Kennebec Registry of Deeds; thence westerly in the southerly line of lots numbered nineteen (19) and eighteen (18) two hundred and eight (208) feet to the southwest corner of lot numbered eighteen (18); thence northerly in the westerly line of lots numbered eighteen (18) and sixteen (16), one hundred and twenty (120) feet to the northwest corner of lot numbered sixteen (16); thence westerly on the extension of the north line of said lot numbered sixteen (16), thirty (30) feet; thence southerly on the easterly line of lots numbered fifteen (15), fourteen (14), thirteen (13), and twelve (12), two hundred (200) feet; thence at right angles easterly thirty-four (34) feet more or less to westerly line of lot numbered eight (8); thence northerly on the west line of said lot numbered eight (8), forty (40) feet more or less to the northwest corner of said lot numbered eight (8); thence easterly two hundred and three (203) feet along the north line of lots numbered eight (8) and four (4) to said Northern Avenue; thence northerly on the west line of said Northern Avenue, forty and three tenths (40.3) feet to the point of beginning.
