Know all men by these presents,

That I, S, Sewall Webster, Jr., of Augusta in the County of Kennebec and State of Maine,

in consideration of one dollar and other valuable consideration

paid by City of Augusta, a municipal corporation organized by law and having a place of business in the City of Augusta in said County of Kennebec and State of Maine,

the receipt whereof I do hereby acknowledge, do hereby give, grant, bargain, sell and convey, unto the said City of Augusta, its successors

and assigns forever, a certain lot or parcel of land located in said Augusta on the east side of the Kennebec and on the south side of Riverside Drive, so-called, more particularly described as follows, to wit:

with reference to Street Plan of S.S. Webster, Jr., dated February 22, 1955, on file at the Kennebec County Registry of Deeds, Plan Book 17B, Page 204, the grantor hereby grants, bargains, sells and conveys, Tracy street as mentioned on said plan beginning on the southerly side of Riverside Drive and running to the northerly side of Spencer Street extended westerly; Thompson Street from the northeasterly side of Tracy Street to the northeasterly side of Walden Street extended northerly; Campbell Street from the southerly side of Thompson Street to the northerly side of Spencer Street; and Spencer Street from the southwesterly side of Tracy Street extended southerly to northeasterly side of Campbell Street.
