A certain lot or parcel of land situated on the west side of the river in Augusta, Maine: Beginning at a point on the southwesterly side of the Townsend Road, so-called, located 100 feet northwesterly from the northwesterly corner of Lajoie land, said point also being the northwesterly corner of Lot No. 1 as shown on "Plan of Hilltop Development, Augusta, Maine dated July 1961, made by Walter S.
