In Common Council

August 17, 1850

The President being absent, the Common Council was called to order by the Clerk.

Report of Committee on New Streets of the laying out of a new street on the south side of Grove Street, on petition of A. T. Ellis et als, was accepted in concurrence.

The undersigned inhabitants of said City would respectfully represent that they are desirous that a street should be laid out and established commencing on Grove Street at a point opposite to the east end of Chandler Street, and running southerly, to near Daniel Bailey's house and from thence northerly to Grove Street, past the house of Joshua L. Heath, and pray that your honorable body to take the necessary measures to layout and establish the same and as in duty bound will ever pray.

The Committee on New Streets to whom was referred the petition of A. T. Ellis and others for a new street from Grove Street near the east end of Chandler Street, southerly to near Daniel Bailey's house; thence northerly to Grove Street near the house of Joshua L. Heath, and on which the City Council directed notice to be given of their intention to layout said street on the eleventh day of June 1850 at 2 o'clock at the house of said Ellis, ask leave to report.

That in accordance with said notice which is herewith returned, copies of which were posted according to law seven days previous to the said eleventh day of June, we assembled at the time and place mentioned in said notice and laid out a street as follows, viz:

Beginning at Grove Street at a post in the northeast corner of James W. North's lot on which stands his dwelling house being Lot No. 17 on Abbott's plan of the Gage Estate; thence running South about 19 degrees East in the easterly line of Lots No. 17, 16, 15 and 14 to a stone being the southeast corner of Lot No. 14 about nineteen and three fourths rods; thence about 25 feet to the northwest corner of Lot No eleven; thence in the north line of said Lot No. eleven, four rods to the northeast corner thereof; thence on the same course of said north line of Lot No. 11 being, about South 78 degrees East to the west line of Lot No. 7 about 32 feet; thence North about 9 degrees East in the west line of Lots No. 7, 6, 5, & 4 to the

northwest corner of No. 4, about two hundred and thirty-five feet; thence North about 15 degrees West in the west line of Lots No. 3, 2, and 1 to Grove Street about one hundred and sixty-five feet; the above line of lots being as on Abbott's plan of the Gage Estate. The above street to be 27 feet wide for the first six rods and the remainder thirty feet wide and to be north and east of the first three courses and distances and north and west of the two last courses, and on the fifteenth day of June instant, we filed in the City Clerk's office the minutes of the above street as laid out by us. We award no damages. Time of services of Engineer two hours.

Said street passes over a reservation made by the former proprietor of the Gage Estate for a street for the owners of house lots abutting thereon.

That in conformity with a notice posted up on the 13<sup>th</sup> day of May 1851 in two public places, of the intention of the City Council to layout the same on the 22<sup>nd</sup> day of May at 4 o'clock p.m. at the house of Daniel Bailey, your Committee met at the time and place mentioned in said notice and proceeded to layout the same as follows, viz:

Beginning at the termination of Crescent Street and running south as far as the south line of land owned by Gilbert Pullen, being about ninety feet and to be a continuation of Crescent Street and to be of the same width.

There is no damage for land and the cost of making the road will be about five dollars.
