


ORDERED, That a portion of Winthrop Court as described below be discontinued and no public Easement retained.



Young (City of Augusta Tax Map 34, Lot 134); Thence running southerly at a right angle 26 feet more or less to the south line of Winthrop Court; Thence running easterly S 58° 38' E 95 feet more or less along the south line of Winthrop Court to the easterly end of Winthrop Court as accepted February 17, 1913; Thence running northerly 26 feet to the point of beginning.

Meaning and intending to describe a portion of the easterly most terminus of Winthrop Court 95 feet more or less in length and 26 feet more or less in width as accepted February 17, 1913.



