Re: Possible Amendments to Manager's Proposed 2018/2019 Budget

To facilitate Council adoption of a final budget for the coming fiscal year (and consistent with your recent budget deliberations, Ralph St. Pierre and I have prepared five draft amendments to my original budget proposal. They include an amendment that would adopt the recommended additions to revenues and reductions in expenditures that were outlined in my memorandum to you dated May 21<sup>st</sup> that increased valuation by \$30,372,000; that estimates that Homestead Reimbursement and Business Equipment Tax Exemption will each be \$25,000 higher; and that adjusts expenditures to a net reduction of \$115,614 (a copy of that memo is included for easy reference.)

A second proposed amendment, coming as a result of instructions you gave me last Tuesday evening, would reduce General Fund expenditures by an additional \$25,000 and restore funding for Parks/Cemeteries by the same amount to be used for "curb appeal" work this summer.

Amendments 3, 4, and 5 are variations that address the Council intention to adjust the School Department by \$300,000. #3 would reduce department spending by that amount. #4 would reduce spending by \$150,000 and allow another \$150,000 to be taken from School fund balance. #5 would allow the School Department to maintain its proposed spending level by permitting it to take an additional \$300,000 from its fund balance.
