Re: Meal Centers and Food Pantries

The Council stated that they wanted to allow Meal Center's and Food Pantries as Permitted Uses in the RD and CB zoning districts. In order to accomplish this, an amendment to the ordinance language on the agenda would need to be offered as follows:

Amend the language in front of the council to read

"and the new use, Meal Center and Food Pantry, shall be added to the Table of Uses (300 Attachment 4) under the institutional heading as a Conditional Use (designated in the table with a CU) in the following zoning districts:

RD, BP, KBD1, KBD2, CB, CC, CD, PD, PD2; and as a Permitted Use (designated in the table with an X) in the following zoning districts: RD and CB.
